Maintaining the security of your data is a priority to our business. We are committed to protect your privacy rights. This Privacy Policy explains in detail the types of personal data we may collect and explains how we will store and handle that data and keep it safe.

### Collection and Use of Personal Information

Customer Data: We may collect and use information about you, or individuals at your organisation, to process any orders, manage your account and to communicate with you. The data we collect contains names, addresses, telephone numbers, e-mail addresses, debit/credit card details and any other necessary information to ensure our relationship runs smoothly.

Suppliers Data: We need a small amount of information from our suppliers to ensure that the business runs smoothly. We need contact details of relevant individuals at your organisation so that we can communicate with you. We also need other information such as your bank details so that we can pay for the products/services you provide.

Other Data: We also may hold names, addresses, bank details and any other contact details to enable the company to comply with legal requirements.

### How we collect your information

The information we hold about you comes from the way you engage with us such as; Trade Shows, order forms, via telephone, post or email.

### Who we might share your information with?

We will only share your data with third parties to help us provide a better service for you, for example; giving your address to a courier so they can deliver your order.

### Access and rights to your personal information

As a data subject, you have a number of rights. You can:

- Access and obtain a copy of your data on request;
- Require the organisation to change incorrect or incomplete data;
- Require the organisation to delete or stop processing your data, for example where the data is no longer necessary for the purpose of processing; and
- Object to the processing of your data where Indulgence Ltd/Tianguis Jackson is relying on its legitimate interests as the legal ground for processing
